INDUSTRIALS: BUILDING PRODUCTS

- The Building Products sector continues to benefit from consumers spending to remodel their homes since the start of the COVID-19 global pandemic in March 2020. The stay at home remodeling demand has been supplemented by remodeling demand driven by a record used home sales market, as new homebuyers improve their newly acquired properties.
- As was the case throughout 2020, Building Products remains a highly active M&A sector with deal volume being driven by both strategic and financial buyers. We anticipate continued robust activity within Building Products throughout the remainder of 2021 as consumers continue to invest in home renovations, driving industry revenues and continued M&A.


