Sector Update

- M&A Activity Rebounding: M&A activity in the chemical distribution industry has been steady since Q3 2023, driven by strategic acquirers seeking to expand product lines, geographic reach, and end-market exposure.
- Private Equity Interest While private equity remains cautious, firms continue to target niche and specialty distributors with high-value services, defensible margins, and strong customer relationships.
- End of Destocking Driving Volume Growth: Chemical manufacturers are seeing improved sales volumes as destocking subsides.
- High-Growth Industry Expansion: Chemical applications in semiconductor and electronics products manufacturing are driving demand for specialty chemicals.
- Reshoring & Supply Chain Shifts: Chemical manufacturers are diversifying supply chains and onshoring production to mitigate geopolitical risks, benefiting regional distributors with localized capabilities and strong supplier relationships.


