Sector Update

- M&A Activity: Strategic buyers continue to consolidate the industry, as buyers focus on acquiring companies that offer complementary products and services, thereby enhancing their market reach and operational efficiencies.
- Broad Interest: Both private equity and strategic buyers remain highly active in the market, attracted by missioncritical applications, fast-growing end markets, and highvalue services.
- Equipment Replacement: Many industrial facilities still operate outdated hydraulic and pneumatic systems, driving steady demand for replacements and system upgrades.
- Value-Add Attraction: Distributors offering MRO support and engineering expertise have become increasingly attractive to buyers, as they play a pivotal role in reducing downtime and improving system efficiencies.
- Fragmentation: The industry remains heavily fragmented, with thousands of small and mid-sized distributors often focused on specific geographies and end markets. This structure offers buyers consistent rollup opportunities to expand their geographic reach and technical capabilities.


