Sector Update

- Work Force Shortage: The shortage of healthcare professionals, especially nurses and allied health workers, is a primary driver for healthcare staffing firms. As hospitals and health systems struggle to maintain full staffing levels, they increasingly turn to staffing providers to fill labor gaps.
- Travel Nurses: Travel nurses are an essential labor solution for health systems facing acute short-term shortages. According to the U.S. Bureau of Labor Statistics, over 275,000 additional nurses will be needed by 2030, highlighting the need for healthcare staffing companies to fill the nurse labor gap.


