Sector Update

- Private Equity Consolidation: Private equity firms have become increasingly active in the gastroenterology sector. Today, over 10% of America's 14,000 gastroenterologists are linked to PE-backed platforms—a figure that continues to grow as these platforms expand.
- Aging Demographic: The U.S. population aged 65 and older is projected to rise from 46 million in 2016 to 98 million by 2060. As this group faces greater risk for GI diseases, screening guidelines have lowered the recommended age, broadening the pool of patients needing care.
- Technological Innovations: Advances in equipment, tools, and artificial intelligence are reshaping the industry. Al use has increased adenoma detection rates by 20%, improving both clinical outcomes and economic value for gastroenterology practices.
- Strong Sector Tailwinds: The future of gastroenterology looks robust, fueled by demographic shifts, growing disease prevalence, wider screening recommendations, and innovation. Altogether, these factors are expected to drive the U.S. gastroenterology market from \$10.9 billion in 2025 to \$18.7 billion by 2034.


