Sector Update

- Consumer Demand: Consumers have continued to drive demand in recent years due to treatment becoming more accessible and socially accepted. The U.S. aesthetic medicine market size was \$43.4 billion in 2024, and is expected to reach around \$136.7 billion by 2033, expanding at a CAGR of 13.6%.
- Fragmented Market: The medical aesthetic market is highly fragmented with several independently owned businesses across the United States. Private equity views this as an attractive opportunity to consolidate multiple businesses and diversify sources of revenue, while streamlining operations across their platforms.
- Aging Population: The aging population is expected to continue to fuel the aesthetic medicine market with the 40 to 54 age segment accounting for the largest share at 46% of the market.
- Rising Popularity of GLP-1s: The rising popularity of GLP-1 treatments presents a significant opportunity within the industry, as individuals seek out more options to address post weight-loss concerns. Revenue in this subsegment of the market is expected to grow from \$700M to \$2B.


