



Sector Update: Orthopedics

- The orthopedic sector continues to demonstrate resilience and growth, underscored by contributions from the critical subsector of specialty orthopedic practices and outpatient surgical centers. The subsector's expansionary tailwinds are driven by an aging population, rising prevalence of musculoskeletal conditions, and a shift toward outpatient and value-based care.
- Demographic and procedural tailwinds are accelerating demand. In 2025, an estimated 61 million adults were 65 or older, projected to reach 95 million by 2050. This growth fuels sustained demand for joint replacements, spine procedures, and other musculoskeletal interventions, supporting practice expansion and investment.
- Private equity and health system capital are flowing into orthopedic practices. Platforms that consolidate regional practices, outpatient centers, and surgical facilities are expanding rapidly, mirroring the shift toward centralized, scalable care delivery models.
- Patients and providers increasingly prefer specialized, high-quality orthopedic services. Practices offering minimally invasive procedures, sports medicine, and sub-specialty care are commanding premium valuations, as outcomes and data support care models that gain traction.
